



Philips Respiration E30 Ventilator Limited Warranty

Respirronics, Inc., a Philips company ("Philips Respiration"), warrants that the Philips Respiration E30 Ventilator will be free from defects of workmanship and materials and will perform in accordance with the product specifications for a period of one (1) year from the date of shipment by Philips Respiration to the customer or the end of the COVID-19 emergency use authorization, whichever is shorter. If the product fails to perform in accordance with the product specifications, Philips Respiration will repair or replace – at its option – the defective product, material or part. Philips Respiration will pay customary freight charges from Philips Respiration to the dealer location only. This warranty does not cover damage caused by accident, misuse, abuse, alteration, water ingress, and other defects not related to material or workmanship. The Philips Respiration Service department shall examine any devices returned for service, and Philips Respiration reserves the right to charge an evaluation fee for any returned device as to which no problem is found after investigation by Philips Respiration Service. This warranty is non-transferable and Philips Respiration reserves the right to charge for warranty service of failed product not purchased directly from Philips Respiration or authorized distributors.

Philips Respiration disclaims all liability for economic loss, loss of profits, overhead, or consequential damages which may be claimed to arise from any sale or use of this product. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

This warranty is given in lieu of all other express warranties. In addition, any implied warranties – including any warranty of merchantability or fitness for the particular purpose – are limited to two years. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary by jurisdiction.

2. This warranty is valid for a period of one (1) year from the date of purchase from Philips Resironics or an authorized Philips Resironics dealer or the end of the COVID-19 emergency use authorization, whichever is shorter.
3. If the Product is found to contain a defect of workmanship or materials or fails to perform in accordance with the Product specifications during the applicable warranty period, Philips Resironics will repair or replace, at its option, the defective material or part.
4. The customer is responsible for returning the product to an authorised Philips Resironics dealer, and collecting the product from the authorised Philips Resironics dealer after repair or replacement, at its own cost. Philips Resironics is responsible only for the freight cost of transporting the product between the authorised Philips Resironics dealer and Philips Resironics. Philips Resironics reserves the right to charge an evaluation and postage fee for any returned Product where no problem is found following investigation.
5. This warranty does not cover:
 - a. products purchased outside of Australia or New Zealand;
 - b. damage caused by accident, misuse, abuse, alteration, pest infestation, liquid ingress, and other defects not related to materials or workmanship.
6. The warranty provided by Philips Resironics herein is not transferrable by the Buyer in the event of any sale or transfer of Products purchased by the Buyer from an authorized Philips Resironics dealer.

To the extent permitted by law, where the Buyer has the benefit of an implied guarantee under the Australian Consumer Law, but the Product is not of a kind ordinarily acquired for personal, domestic or household use or consumption Philips Resironics' liability shall be limited, at the option of Philips Resironics, to the replacement or repair of the Product or the supply of an equivalent Product.
